

**14<sup>TH</sup> INTELLIGENCE LAW COURSE APPLICATION INSTRUCTIONS**  
**13-17 August 2018**  
**The Judge Advocate General's Legal Center and School**

This four and a half day course is intended primarily for judge advocates that are new to the field of intelligence law and it is designed to achieve the following objectives:

- a. Introduce attendees to the field of intelligence law; provide a historical context with which to view, understand, and apply existing laws, regulations and policies; and provide an overview of the organization, roles, and functions of the intelligence community;
- b. Provide a basic understanding of the legal framework in which the intelligence community operates, to include the principle sources of intelligence law, with a focus on Executive Order 12333, DoD implementing policy, and the service regulations which implement these authorities;
- c. Introduce principles and mechanisms involved in conducting intelligence oversight;
- d. Provide an introduction to the intelligence disciplines of counterintelligence, human intelligence, signals intelligence, and open source intelligence;
- e. Provide practical experience which will enable new practitioners to identify, research, and address basic intelligence-related legal issues;
- f. Provide an opportunity to engage in discussions of emerging issues and specialized areas of intelligence law to include issues surrounding collection of intelligence in the cyber age;

This course will be a unique opportunity for judge advocates in the intelligence and operational field to gain exposure to the growing field of intelligence law. The course will be held at TJAGLCS in Charlottesville, Virginia.

The course is open to U.S. Government attorneys but is specifically designed for those assigned or pending assignment to a billet where the attorney will be advising on intelligence and intelligence related activities. Security clearance required: SECRET. This course is classified "SECRET."

Those selected for a seat will be emailed registration information at this time and will need to return the registration NLT 9 July 2018. TJAGLCS will enter all selected attendees into the Army Training Requirements and Resources System. If you are selected to attend the course, you will receive a welcome letter containing information on the report time, registration requirements, continuing legal education requirements, uniform/dress standards, lodging, and parking. There is no registration fee for the course.
